

**Course Fee Reimbursement Application Form for the 2009/10 School Year

2. All Parts contained in this Application Form should be completed in block letters with a dark blue or black pen.
3. Serving principals and full-time teachers<sup>2</sup> teaching full curriculum of nursery, lower and/or upper classes in private independent kindergartens or non-profit-making kindergartens not joining the PEVS as from the 2007/08 school year are eligible for course fee reimbursement for one approved course up to the end of the 2011/12 school year (hereinafter individually or collectively referred to as 'applicant'). Supply teachers or temporary teachers employed on a monthly or daily basis are not eligible to apply for course fee reimbursement.
4. Eligible applicant is entitled to claim reimbursement for up to 50% of the course fees<sup>3</sup> for an approved certificate course in Early Childhood Education (ECE) or a degree course in ECE and a certification course for kindergarten principals, capped at \$60,000, whichever is less.
5. Eligible applicant is entitled to course fee reimbursement on a yearly basis upon successful completion<sup>4</sup> of the relevant term(s)/year of studies of the course which the course fee has been fully paid.
6. Applicant should submit the duly completed Application Form together with original course fee receipt(s) and a self-certified true copy of all supporting documents to the Education Bureau (EDB) through his/her serving kindergarten. The deadline for application is 15 October, 2010.

<sup>1</sup> Kindergartens (KGs) include kindergarten-cum-child care centres subsequent to harmonisation of pre-primary services as of 1 September 2005.

<sup>2</sup> In accordance with the relevant provisions of Education Ordinance, teachers teaching in kindergartens shall be registered teachers or permitted teachers.

<sup>3</sup> The course fee is confined to tuition fee. Other fees and charges, such as registration fee, student union membership fee and caution money, etc., are not included.

<sup>4</sup> 'Successful completion' means that the applicant must pass the course assessment as required by the institution. Each institution would conduct its own assessment of the study, including but not limited to examinations.

**To: The Government of the Hong Kong Special Administrative Region (as represented by the Permanent Secretary for Education of Hong Kong) (“HKSAR Government”)**

1. In consideration of the HKSAR Government considering and/or approving this course fee reimbursement application, I, the undersigned, my particulars being provided in Part I of this course fee reimbursement application form (‘Application Form’) hereby undertake, acknowledge and agree as set out in Clauses 2 to 14 below.
2. I hereby undertake that I am a \*full-time teacher teaching full curriculum of nursery, lower and/or upper classes in the kindergarten specified in Part II of this Application Form / \*serving principal in the kindergarten specified in Part II of this Application Form.
3. I have carefully read and fully understood the ‘Guidance Notes on Application for Course Fee Reimbursement’ for serving principals and teachers of private independent kindergartens and non-profit-making kindergartens not joining the Pre-primary Education Voucher Scheme. I hereby declare, undertake and warrant that all information contained in this Application Form and supporting documents provided (‘Information’) is up-to-date, true, accurate and complete. I understand and agree that if any Information is false, incorrect, incomplete or misleading, this application will immediately become invalid and I may be liable to be sued for misrepresentation and/or breach of contract, and further, be prosecuted for a criminal offence.
4. I understand and agree that my Application Form will not be processed if I fail to provide all the information required.
5. I agree that the personal data provided in this Application Form and the supporting documents referred to in Clause 3 above may be used by the Education Bureau (‘EDB’) or the agents or contractors of the HKSAR Government for the purposes of processing my application for course fee reimbursement, data authentication, fraud detection and prevention, recovery of course fee reimbursed or any part thereof, administrative purpose and statistics and research purposes. I also give consent to EDB disclosing the Information to other Government bureaux and departments or relevant non-Government bodies for those purposes. I understand that in accordance with Sections 18 and 22 and Principle 6 of Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486 of the Laws of Hong Kong Special Administrative Region (‘Hong Kong’), I, being the data subject, have the right to request access to and corrections of the personal data provided in this Application Form and the said supporting documents.
6. I agree and understand that the HKSAR Government has the right to review and revise the arrangements and requirements regarding the course fee reimbursement and adjust my entitlements at any time and from time to time as the Permanent Secretary for Education may deem necessary in order to ensure that the targets of upgrading professional qualifications of principals and teachers are properly achieved. I undertake to refund to the HKSAR Government all overpayment made to me relating to the course fee reimbursement forthwith upon demand (unless otherwise specified by the HKSAR Government in writing).

7. I declare and undertake that:-
  - (a) up to the date of this Undertaking and Declaration, I have not applied for or obtained; and
  - (b) until and unless this application has been rejected by the HKSAR Government, I shall not apply for or obtain, any other publicly-funded financial assistance for the course, modules or units of studies as specified in this Application Form.
8. I shall return immediately upon demand all the reimbursed course fee to the HKSAR Government should I fail to successfully complete the full course specified in Part III of this Application Form or should I be in breach of Clause 7 above.
9. Whenever I apply to other kindergarten(s) or pre-primary educational institution(s) for other teaching post(s), I shall declare my claim for course fee reimbursement from the HKSAR Government and provide such details as the potential new employer(s)/kindergarten(s) may request before entering into the new employment agreement(s).
10. I shall notify the HKSAR Government in writing forthwith upon my termination of employment with the kindergarten and furnish such information and documents as the HKSAR Government may request.
11. I intend to continue serving as a principal / teacher in the kindergarten specified in Part II of this Application Form or any other kindergarten in Hong Kong for at least one full year upon my successful completion of the full course specified in Part III of this Application Form. For the purpose of this Undertaking and Declaration, “successful completion” of the course means that I must pass the course assessment as required by the institution providing the relevant course and obtain documentary proof of successful completion of the course of study that may include a certificate of award, a letter or a transcript from the institution certifying that I have passed the relevant course assessment.
12. I undertake to forthwith notify the HKSAR Government in writing of any change of my residential address, correspondence address, facsimile number, telephone number or email address.
13. This Undertaking and Declaration shall be governed by and construed in accordance with the laws of Hong Kong and I and the HKSAR Government shall irrevocably submit to the exclusive jurisdiction of the Courts of Hong Kong.
14. I have read the provisions of this Undertaking and Declaration carefully and fully understood my obligations and liabilities under this Undertaking and Declaration.
