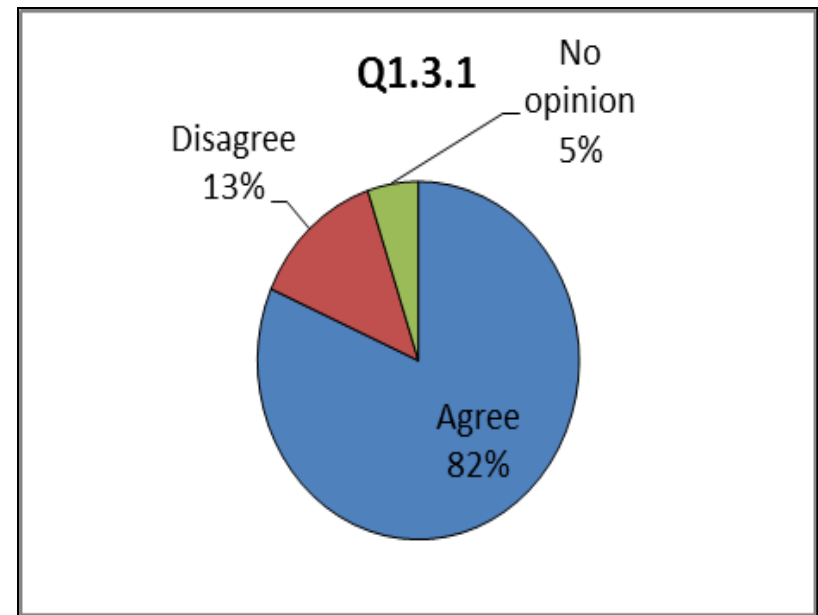

Total	412	100%

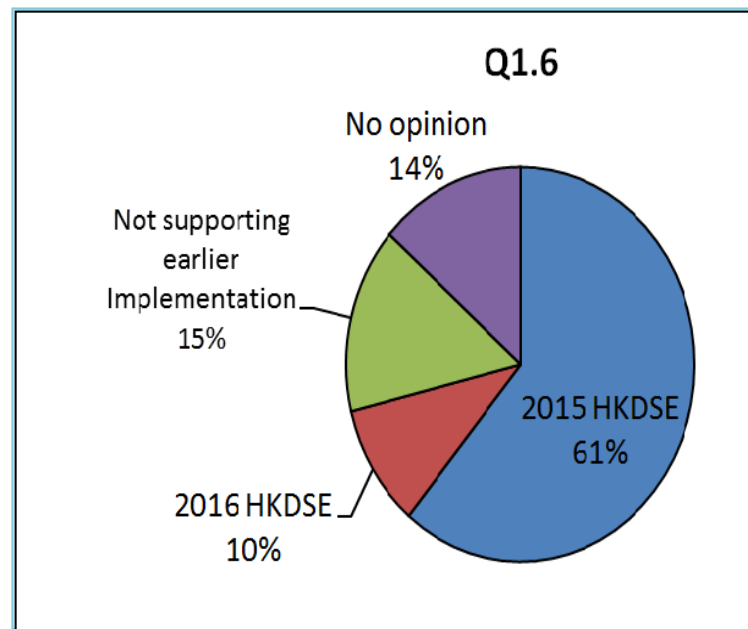


School Survey Results

- 1.6 It is envisaged that separate grading and reporting of HKDSE BAFS Examination results would not have major implications on the learning and teaching of the subject and hence could be implemented earlier starting from the 2015 or 2016 examination, provided that this is supported by the majority of schools.

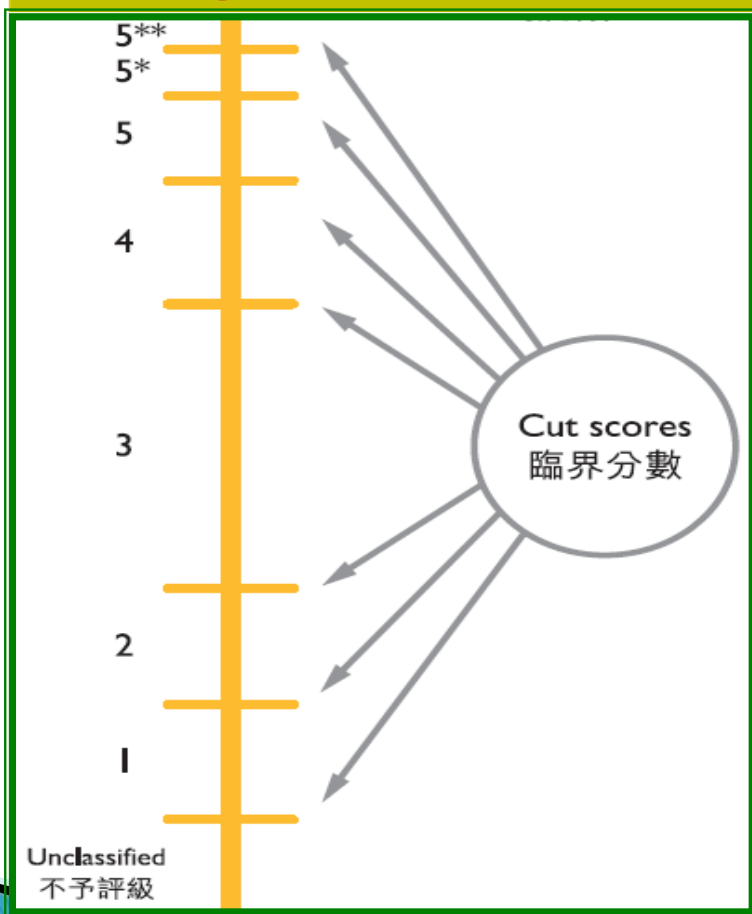
Separate Grading and Reporting

- ❑ Change in the processing of marks: **No equating of Paper 2A and 2B scores**
- ❑ Change in the grading of results: **Separate panels of judges to ascertain the cut scores for the subject results of candidates taking different elective modules**
- ❑ Change in the reporting of results: **Elective indicated on the results notice and HKDSE Certificate**

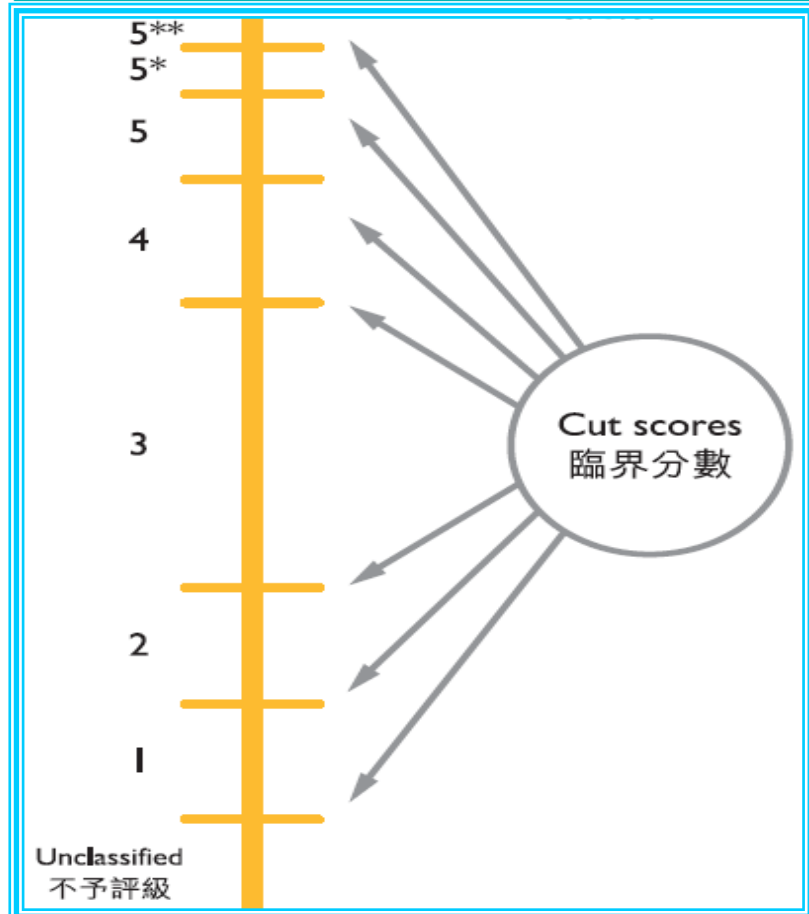


Separate Grading

Separate Grading and Reporting

- **No change in the standards-maintenance procedures** \Rightarrow determining the cut scores for L1 to L5[#] with reference to
 - ✓ Level descriptors,
 - ✓ Live performance,
 - ✓ GAI (separate GAIs for the two groups),
 - ✓ 2012 and 2013 library scripts, etc

[#] Top 10% of L5 for L5** and the next top 30% for L5*



Other developments

- ✓ **Closely monitoring and reviewing**
 - ▣ the existing curriculum and assessment framework of the trimmed BAFS curriculum
(first examination to be conducted in 2016)
 - ▣ the implementation of separate grading and reporting of the subject results
