



#### **Learning and Teaching**

**Course Title** : **Law Enforcement in Hong Kong**  
**Area of Studies** : **Business, Management and Law**  
**Course Provider** : **School of Continuing Education, Hong Kong Baptist University**

In Law Enforcement in Hong Kong, student-centred learning and teaching activities are designed to enable students to understand fundamental theories and concepts, develop their generic skills, and address their career aspirations in law enforcement.

Different modes of activities are employed to provide students with a systematic understanding about the context (e.g. lectures on law enforcement and criminal justice system in Hong Kong) and eye-opening opportunities to experience the complexity of the context (e.g. visits to law enforcement organisations).

Students acquire an understanding of the requirements, fundamental knowledge and skills essential for further learning within the area through learning-by-practising opportunities in an authentic or near-authentic environment (e.g. role play exercises as law enforcement officers in case investigation from initial incident, criminal intelligence gathering and analysis to court disclosure; experience sharing by industry practitioners on crime scene investigation, and staff recruitment and personal qualities of various disciplined services).

Students are also encouraged to develop and apply conceptual, practical and reflective skills to demonstrate entrepreneurship and innovation (e.g. develop a feasible and effective proposal to change the traditional culture of law enforcement to a serving culture for citizens in the disciplined services). Students are given opportunities to integrate the knowledge and skills acquired and consolidate their learning (e.g. an integrated project provides students with the opportunity to apply the knowledge and skills acquired to identify a social issue (e.g. juvenile delinquency) in Hong Kong and analyse the relationship between the social issue, society, current criminal justice system and law enforcement system, and to make realistic suggestions in preventing crimes arising from such social issue).

#### Curriculum Pillars of Applied Learning in Context – Law Enforcement in Hong Kong

Upon completion of the course, students should be able to:

- describe the key elements of crimes, criminal law and the criminal justice system in Hong Kong and rights and responsibilities of citizens;
- explain the roles, scope of work, functions and the inter-relationship of the law enforcement agencies in Hong Kong and their importance to the continued development of society;
- apply the criminal justice principles in appraising law enforcement operations;
- explain the job requirements, duties, essential attributes, physical and wellness training, code of conduct and the value systems in the Hong Kong Police Force and other disciplined services; and
- develop self-understanding for further studies and career development in the related field.

Through the specific contexts related to the course, students have different learning opportunities, for example:

#### **1. Career-related Competencies**

- describe the roles and appraise the importance of criminal justice system in maintaining order and stability in a society;
- demonstrate a fundamental understanding of criminal behaviour and the criminal law that supports the law and order of society;
- distinguish the roles, functions and structure of different law enforcement agencies in Hong Kong, and their relationship with the community;
- recognise the job requirements and personal qualities required by different law enforcement agencies;
- develop fitness training exercises that meet the standard required by major law enforcement agencies; and
- plan future study and career roadmap in the field of law enforcement.

#### **2. Foundation Skills**

- communicate concisely and effectively in both verbal and written forms in role play, case discussion, project presentation, written reports and interview simulations;
- apply information technology skills in searching information online, case analysis and presentation; and
- analyse crime data and develop effective resources planning on crime prevention.

**3. Thinking Skills**

- demonstrate ability to identify problems and apply problem solving and decision making skills in a simulated law enforcement work environment;
- analyse evidence and information to draw logical inference in case investigations;
- apply critical thinking skills in understanding criminal behaviour; and
- develop understanding of inter-relationship of various entities, evidence and events through criminal case investigation.

**4. People Skills**

- demonstrate effective interpersonal skills when interacting with people of different cultures and background in a simulated law enforcement environment;
- develop collaborative and team building skills in group project activities; and
- practise self-reflection and self-management in role play and assessment activities.

**5. Values and Attitudes**

- recognise integrity and honesty of law enforcement officers in executing their duties;
- recognise the values and attitudes that need to be observed by law enforcement officers;
- demonstrate positive attitudes, enthusiasm and a willingness to learn about the knowledge on criminal justice and law enforcement; and
- show self-confidence, objectivity and a high degree of responsibility in presenting case for prosecution in law enforcement context.
