Operating Expenses Block Grant (OEBG) Consolidated Subject Grant for Home Economics / Technology and Living Consumables General Guidelines on the Use

To enhance the teaching of Home Economics / Technology and Living, the Education Bureau allocates the Consolidated Subject Grant to schools to replace the subject and curriculum grants from 2009/10 to 2010/11 school years (EDB Circular Memorandum No. 110/2009). This grant could be used for the purchase of ingredients / materials for practical lessons or minor repairs / replacements of small number of equipment used for Home Economics / Technology and Living classroom activities.

The purchase of consumables should be relevant to Home Economics / Technology and Living classroom activities and the school curriculum. Every effort should be made to maximise the cost effectiveness and the utilization of the grant. Students may be requested to bring along small amounts of ingredients / needlework accessories for use in some of the practical lessons. However, should individual student expresses difficulties in doing so, further assistance should be given. Collection of fees from student is not recommended.

A separate ledger of all income and expenditure chargeable to the recurrent grant of Home Economics / Technology and Living must be kept. The following materials may be purchased using the recurrent grant:

Needlework/Dress and Design

- 1. Commercial patterns and teaching charts/aids.
- 2. Paper and other materials:

For example: drafting paper, tracing paper, tissue paper, card or cardboard, pens for sketching, adhesives, polystyrene board, cork, etc.

- 3. Fabrics.
- 4. Haberdasheries.
- 5. Addition of Needlework gadgets.

For example: tracing wheels, ripper, gauge, special attachments for sewing machines.

6. Miscellaneous,

For example: magazines for cutouts, sharpening of scissors.

Home Management

- 1. Cleaning materials including kitchen cloths.
- 2. Paper and other materials:

For example: Kitchen paper, doilies, paper cases, plastic wraps, foil, etc.

- 3. Food.
- 4. Chemicals.
- 5. Samples of teaching aids,

For example: samples of wall/floor coverings, furnishing fabrics, etc.

- 6. Addition of Home Management gadgets.
- 7. Miscellaneous,

For example: replacements for the first aid box, local magazines for

cutouts, sharpening of knives etc.

學校用這撥款所購買的消耗性用料應適用於學校課程及家政或科技與生活科課程活動,並應盡量使用這款項以提高成本效益。學校可要求學生帶備少量食用材料/針黹用料以供部分實習課堂之用,如個別學生對此要求表示有困難,學校應給予進一步援助。局方建議學校不應向學生收取有關費用。
