## **Technology Education Good Practices Sharing Scheme**

(Note: This circular memorandum should be read by all secondary school heads and teachers.)

### **Summary**

The purpose of this circular memorandum is to inform secondary schools of the Technology Education Good Practices Sharing Scheme and to encourage school heads, teachers and students to participate.

#### **Aims**

## Technology Education Good Practices Sharing Scheme

## 1. Background

Technology Education Key Learning Area (KLA) is one of the eight KLAs in the School Curriculum which all students are entitled to learn. It comprises Business Education, Computer Education, Design and Technology Education as well as Home Economics Education. They all share the common rationale and purposes of Technology Education (TE), i.e. the learning of how human beings solve their daily problems and how to replicate and transfer the process to solve new problems that arise from time to time.

TE emphasizes on awareness, exploration, experiencing, specialization and life-long learning. Students develop their knowledge, generic skills, values and attitudes through the study of knowledge contexts in technology, process in technology and impact of technology.

TE is implemented in schools in various modes, including subject-based teaching, school-based integrated TE KLA collaborative teaching, theme-based teaching, and life experience learning.

Schools have been encouraged to make references to the following curriculum documents for all necessary details and strategies for implementing TE in secondary schools:

- (a) Learning to Learn Life-long Learning and Whole Person Development (CDC 2001)
- (b) Basic Education Curriculum Guide (CDC 2002), and
- (c) Technology Education Key Learning Area Curriculum Guide (CDC 2002).

#### 2. Objectives of the Good Practices Sharing Scheme

- (a) To recognize the quality work and contribution of schools, including school heads and teachers in effective design, development and successful implementation of TE in the whole school curriculum, and
- (b) To recognize quality work of students in realizing the aims of education and goals of school curriculum through TE KLA.

Ten nominations from each category will be selected for the Technology Education Good Practice Award, categorized in terms of (a) curriculum design, (b) curriculum leadership for the teaching profession, and (c) remarkable performances and achievements for students. ## 7. Scope and Format

## (a) Good Practice for Curriculum Design in Technology Education

## Scope

- ➤ Curriculum Design of TE KLA of various level(s) in terms of
  - (i) individual TE subject, or
  - (ii) integrating subjects within TE KLA, or
  - (iii) integrating TE subjects across KLAs.

## **Format**

- Nominees are required to provide evidence such as school plans, teaching schemes, lesson plans, or other appropriate documents; together with related student work such as work sheets, assignments, or others.
- The evidence provided could be in any format or medium.

#### (b) Good Practice for Curriculum Leadership in Technology Education

#### Scope

Curriculum leadership as demonstrated by school heads, TE KLA Co-ordinators, Panel Chairpersons, or teachers of TE KLA in promoting quality learning and teaching of the TE curriculum in the school as a whole.

#### **Format**

- Nominees are required to attend a 20-minute interview and explain how TE has been promoted under his / her / their leadership with supporting evidence such as school plans, meeting minutes, or others.
- The evidence provided could be in any format or medium.

### (c) Student Ambassador of Technology Education

### Scope

- ➤ Performance in TE KLA at individual, school or community levels
- ➤ Attitudes towards learning of TE

#### **Format**

- Evidence of performance / achievement in academic and co-curricular activities of TE KLA, such as class work, school clubs, competitions, and/or community services.
- A piece of reflection on the topic of "My learning experience of TE" in written text, audio-visual, or other electronic form, such as self designed posters, video / sound clips, 'blog', or web pages.

#### 8. Adjudication

Evaluation criteria for outstanding practice for each category will be announced at the Briefing Session and then posted on CDI Web Page (<a href="http://www.emb.gov.hk/cd">http://www.emb.gov.hk/cd</a>). Judging panels comprising academics, professionals in the education sector, representatives of related professional bodies and organizations will be formed for each category.

#### 9. Prizes

Trophies and certificates will be awarded to the best ten participants of each category.

## 10. Award Presentation Ceremony and Post-Activity Sharing Session

- All nominees of the Scheme will be invited to an Award Presentation Ceremony to be held in November 2006.
- The best ten participants of each category will be invited to share their good practices and quality work at the Post-Activity Sharing Session and other related professional development programmes.

## 11. Originality

All entries must be original and any infringement or misrepresentation of ownership will be disqualified.
