To: Supervisors of all Direct Subsidy Scheme (DSS) Schools

Dear Sir/Madam,

Refinements to the Operation of the Governance Review Sub-committee

Governance Review Sub-committee or functional committee of similar nature (collectively named as GRSC below) has been established in DSS schools to assist the School Management Committee (SMC) / Incorporated Management Committee (IMC) in reviewing their key management and financial control systems and procedures since the 2014/15 school year. With the support of the GRSC in the past two review cycles¹, most of the DSS schools have already made good attempt by putting in place the required school-based policies and procedures as appropriate.

According to the EDB Circular No. 7/2012 on *Improvement Measures to Strengthen the Governance and Internal Control of Direct Subsidy Scheme (DSS) Schools*, in principle, the GRSC is required to complete a review of all the school-based policies and procedures under the three domains (namely human resources management, financial and resources management, and school fee remission and scholarship schemes) within a 3-year cycle as specified at <u>Annex 1</u>. As the culture of continuous self-improvement has already taken root in DSS schools based on the experience gained, the following refinements to the operation of the GRSC will be made starting from the third review cycle:

- (a) The review cycle will be extended from 3 years to 6 years with effect from the 2020/21 school year. Therefore, the third review cycle will cover the period from the 2020/21 to 2025/26 school years.
- (b) The prevailing requirement of reviewing all the key areas specified in the EDB

¹ The first and second GRSC 3-year review cycles cover the periods from the 2014/2015 to 2016/17 school years and from the 2017/18 to 2019/2020 school years respectively.

Circular No. 7/2012 in a review cycle will be cancelled starting from the 2020/21 school year. The GRSC will be required to submit the proposed review schedule as well as review areas to the SMC / IMC for deliberation and endorsement at the beginning of each review cycle. Flexibility will be given to the SMC / IMC to decide the review schedule and areas to be reviewed according to the GRSC's recommendations and the school's needs.

To facilitate DSS schools in making their review schedule and deciding their review areas, a template is devised for schools' use at <u>Annex 2</u> together with a sample at <u>Annex 3</u> for reference. Schools may adapt the template to suit their own needs. The template has been posted onto the EDB website at the following address:

As affected by the epidemic, some GRSCs may not be able to complete reviewing all the required areas in the second review cycle by the end of the 2019/20 school year. They may include those outstanding areas in the review schedule of the third review cycle. DSS schools are required to provide a copy of the review schedule to the EDB by end-December of the first year of each review cycle for record purpose, and if necessary, the EDB will provide advice on the review schedule to individual schools. For instance, the review schedule of the third review cycle covering the period from the 2020/21 to 2025/26 school years should be submitted to the EDB by 31 December 2020. If there are any changes to the review schedule, schools are required to submit a revised review schedule to the EDB within a month.
