School-based Medium of Instruction Plan for Junior Secondary Levels (Arrangements for Secondary 1 Students in the 2012/13 School Year)

In accordance with Education Bureau (EDB) Circular No. 6/2009, schools are required to report annually to the EDB their school-based medium of instruction (MOI) arrangements including any subsequent revisions. Please complete the "School-based Medium of Instruction Plan for Junior Secondary Levels (Arrangements for Secondary 1 Students in the 2012/13 School Year)" at <u>Annex I</u> and return it to your respective Senior School Development Officer **on or before 10 October 2011** for vetting purposes. A copy of your school-based MOI plan for the 2010/11 and 2011/12 Secondary 1 cohorts of students is attached at <u>Annex II</u> for your easy reference.

I wish to take the opportunity to remind you that schools are required to adhere to the MOI fine-tuned framework when devising their MOI plan. Schools should continue with the existing practice of providing information about subjects offered with the MOI adopted under the prescribed format and explaining the arrangements in the "Whole-school Language Policy" under "Learning and Teaching Plan of School Characteristics" of the Secondary School Profiles. This will facilitate parents to make school choices for Secondary 1 admission in the 2012/13 school year. Besides, schools are advised to enhance the transparency of the MOI information through dissemination in school website. For details, please refer to EDB Circular No. 6/2009 and EDB Circular Memorandum No. 105/2010, the main points of which have been extracted at <u>Annex III</u> for reference. Please note that the above circular and circular memorandum are still in force.

The gist of the in-service teacher training courses and other professional development activities for the 2011/12 school year is at <u>Annex IV</u> for your reference with a view to facilitating staff deployment. Please visit the Training Calendar System of the EDB for details of individual programmes and make application as and when appropriate.

School-based Medium of Instruction Plan for Junior Secondary Levels (Arrangements for Secondary 1 Students in the 2012/13 School Year)

The school-based medium of instruction (MOI) plan of our school has been devised according to EDB Circular No. 6/2009 "Fine-tuning the Medium of Instruction for Secondary Schools". Our plan applies to Secondary (S) 1 students to be admitted in the 2012/13 school year, and the same cohort of students proceeding to S2 and S3 in the 2013/14 and 2014/15 school years respectively. Our plan, on which relevant stakeholders have been consulted, has been endorsed by the School Management Committee (SMC)/Incorporated Management Committee (IMC) of our school. It is summarised as follows:

Annex II

Main points of MOI Fine-tuning for Secondary Schools

The fine-tuned MOI arrangements for secondary schools have been implemented starting from the 2010/11 school year at Secondary 1 level and progressing each year to a higher form at junior secondary levels.

Framework of MOI Fine-tuning

2. The prescribed criteria underpinning the MOI fine-tuning are "student ability", "teacher capability" and schools having adequate support strategies/measures. The fine-tuned MOI framework is as follows:

- (a) Schools may choose to adopt Chinese as the MOI for teaching non-language subjects. To enhance the English learning environment of students, the percentage of the total lesson time (excluding the lesson time for the English Language) allowed for extended learning activities (ELA) has been increased to a uniform proportion of 25% for each of the junior secondary levels.
- (b) Schools may choose to transform the ELA time into the adoption of English as the MOI in individual non-language subjects up to a maximum of two subjects. Schools are required to make sure that the directions of their whole-school language policy (including the school-based MOI arrangements) and school curriculum should be consistent so as not to compromise students' learning effectiveness. Please refer to paragraph 9 of EDB Circular No. 6/2009 for details of the guiding principles.
- (c) Schools fulfilling the "student ability" criterion, i.e. the average proportion of Secondary 1 intake of a school admitted to a class belonging to the "top 40%" group in 2008 and 2009 reaches 85% of the size of a class (with regard to the allocation class size in 2010, 85% means 29 students), are given professional discretion in the first six-year planning cycle to determine the MOI arrangements in the classes/groups concerned, with regard to other prescribed criteria (including teachers' capability and readiness in EMI teaching and school support measures).

In accordance with the six-year review cycle, we will provide schools with relevant information of their Secondary 1 student profile, based on the Secondary 1 allocation results of 2014 and 2015, for devising school-based MOI arrangements for the second six-year cycle, starting from 2016/17 school year, as part of the Secondary 1 school places application process. Should schools wish to make any changes to their MOI arrangements, they have to announce the changes one year prior to implementation, starting from Secondary 1 and progressing each year to a higher level, to safeguard students' learning effectiveness.

Monitoring

3. In line with the School Development and Accountability Framework, schools are held accountable for their MOI arrangements in respect of the students' learning outcomes. They should incorporate their whole-school language policy (including the MOI arrangements) in the School Development Plan, conduct review annually and reflect the findings in the School Report. They should also report their "School-based Medium of Instruction Plan for Junior Secondary Levels", including subsequent revisions, annually to the EDB. Moreover, the EDB will step up focus inspections and share with schools the observations and findings about learning and teaching from the focused inspections in a briefing session to be conducted in November 2011.

4. The EDB encourages schools to have direct communication with parents to explain the details of the MOI arrangements, instead of providing simplified descriptors or generalising the diverse teaching modes by giving the numbers of classes/groups. In gist, when disseminating information about the MOI modes of teaching in the school website, schools should cover the four main aspects as follows:

- the subject offered to each Secondary 1 class/group and the MOI arrangements for each subject, with a view to facilitating parents to understand the different arrangements of individual classes/groups and the rationales behind such arrangements;
- (ii) the arrangements for assigning Secondary 1 students to individual classes/groups (including the mechanisms for allocating students to classes/ groups), and the arrangements for students when they move up to Secondary 2 and Secondary 3 in the junior secondary stage;
- (iii) in relation to the above, the support by schools to help students bridge over from Primary 6 to Secondary 1 and from junior secondary to senior secondary levels (including how the MOI arrangements adopted at junior secondary levels tie in with the curriculum of non-language subjects at primary and senior secondary levels); and
- (iv) the interface between the MOI arrangements and the whole-school language policy, and the indicators to evaluate the MOI arrangements for enhancing the effectiveness of students' language learning.

5. It has been the stance of the EDB to take immediate action to follow up on schools' promotion practices or dissemination of information which may mislead members of the public. Should any case be substantiated, the school concerned will be required to make immediate rectification. For serious cases, we will issue warnings to schools and make known to the public our follow-up actions as required.

6. The EDB will organise parent briefing sessions in December each year with a view to educating parents that the extent of Chinese or English teaching adopted by individual schools should not be their sole consideration. Instead, they should gather comprehensive information about individual schools and then make balanced decisions on school choices for their children.

Remarks:

- Each of the first four courses consists of 24 hours of lecture on four consecutive weekdays, and 5 hours of post-course support service. Teachers applying for these courses must have met the "teacher capability" criterion for teaching non-language subjects in the English medium. Priority for admission will be given to teachers who have attended the *15-hour Course on Teaching Non-language Subjects in the English Medium* commissioned to the Hong Kong Institute of Education in the 2010/11 school year or have experience in teaching the specific Key Learning Areas in the English medium.
- The fifth course is designed to train up resource persons for schools. Participation will be made on a school basis that no less than two but not more than five key school personnel responsible for implementing English-across-the-curriculum should join the class together. The participants will attend 30 hours of lecture on five consecutive weekdays. Ten hours of post-course support service will be rendered to each participant school.
- The sixth course is the 8-week intensive programme continued to be offered by the Hong Kong Institute of Education.
- Admission will be on a first-come, first-served basis. Applicants will be notified of the application results by the respective institutes not later than 14 calendar days before the commencement of the class they apply for.
- Schools sending teachers to participate in the above programmes will be eligible for hiring supply teachers in accordance with the existing arrangement.

Sharing sessions

• The Education Bureau will continue to organise half-yearly sharing sessions to support schools and teachers in implementing the school-based medium of instruction arrangements. Details will be announced under separate cover in due course.
