Common Examples of Supporting Documents


(A) Identification Documents of Student Applicant

Depending on the circumstances of each applicant, in addition to identity documents, relevant endorsements or landing slips may need to be presented when applying to confirm the student applicant's eligibility for admission to public sector schools. Therefore, please ensure that <u>all</u> identity documents and relevant endorsements/landing slips (if applicable) for the applicants are brought along whenever possible. Failure to verify eligibility for admission to public sector schools may result in the application not being processed further. You may refer to Education Bureau Circular (EDBC) No. 18/2024 titled "Entry of Non-local Children and Children Holding a Form of Recognizance to Schools in Hong Kong".




1. Birth Certificate

Regardless of the student applicant's place of birth, the <u>original and photocopy</u> of the birth certificate must be presented.



2. Other Identification Documents



The above only lists some common examples. After reviewing the student applicant's identity documents, the Education Bureau may request additional supporting documents related to the student applicant.

(B) Academic Certificate with the Highest Level (e.g. Primary 6) of Primary Education Attained/being Attained Shown

- 1. Student handbook[#], with the page containing student's personal particulars duly completed <u>with the student's photo</u> (if applicable) and <u>authorised with the school stamp</u>
- 2. Report card/ academic transcript <u>with the school stamp</u> (excluding documents issued by schools via messaging groups or online platforms)
- 3. Graduation certificate/ leaving certificate for primary education
- 4. Record of attendance issued by the primary school (e.g. letter authorised by the school with the school stamp, school fee receipt, etc.)
- 5. Record card/ Student information card with the highest level of primary education attained or being attained shown with the school stamp

[#For the photocopy, parents are only required to make photocopies of the cover page and the duly-completed page containing student's particulars.]

Note: For documents #1, #2, #4 and #5, the <u>highest level of primary education</u> (e.g. Primary 6) being attached/ attained <u>must be shown</u>.

Documents NOT accepted include:

- Photos of the above documents on mobile devices
- Certificates or records of school acitivities or extra-curricular activities
- Assignments, e.g. homework, test papers, or exam papers
- Photos of the applicant in school uniform attending schools lessons or extra-curricular activities

(C) HK Address Proof

- Stamped tenancy agreement
- Demand note for rates and/or government rent
- Tenancy agreement/ tenant's rent card issued by the public housing authorities
- Residential telephone bills/home broadband bill
- The bills from various utility companies, like Towngas, power companies, Water Supplies Department, etc.

Documents NOT accepted include:

- Bank statement
- Mobile phone bills
- Court summons
- Tax demand notes

Note: If the parent is not the holder of the address proof, the following additional documents should be submitted:

- The photocopy of the identity document of the holder of the address proof; and
- The true copy of the "Authorisation Letter for Use of Address for School Place Application" signed by the holder of the address proof (please see page 4 for the sample of the authorisation letter)
