- Description :** The works include the construction of a 6-storey reinforced concrete lift tower comprising piled foundations at Hong Kong Sheng Kung Hui Bishop Hall Secondary School, a 6-storey reinforced concrete lift tower comprising piled foundations at Po Leung Kuk No. 1 W.H. Cheung College, and a 6-storey reinforced concrete lift tower comprising piled foundations at Lok Sin Tong Yu Kan Hing Secondary School, together with lift installation (by a Nominated Sub-contractor), associated builder's works and building services installations, and all necessary alterations, modification and improvement to existing buildings and subsequent reinstatement. The works at Hong Kong Sheng Kung Hui Bishop Hall Secondary School are scheduled to commence in November 2023 tentatively for completion in August 2025 tentatively. The works at Po Leung Kuk No. 1 W.H. Cheung College and Lok Sin Tong Yu Kan Hing Secondary School are scheduled to commence in November 2023 tentatively for completion in June 2025 tentatively.

- Submission of tenders :** Sealed tenders in duplicate must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box situated in Room 503 on the 5th Floor, Low Block of the Queensway Government Offices, 66 Queensway, Hong Kong. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.
- If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or "extreme conditions after super typhoons" announced by the Government is/are in force at any time between 9:00 a.m. and 12:00 noon on Friday, 31 March 2023, the tender closing time will be postponed to 12:00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the "extreme conditions after super typhoons" announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9:00 a.m. and 12:00 noon on Friday, 31 March 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. - Remarks :** Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Groups A and B for Buildings Category are invited to tender.
- Contractors will be liable to have their names removed from the approved list if they fail or refuse to implement an accepted tender.
