Description :	<p>The works include the construction of a 6-storey reinforced concrete lift tower comprising piled foundations at Caritas Fanling Chan Chun Ha Secondary School, a 6-storey reinforced concrete lift tower comprising piled foundations at CCC Kei Heep Secondary School, two reinforced concrete lift towers with one of 5-storey and one of 4-storey respectively comprising raft foundations at Cheng Chek Chee Secondary School of Sai Kung & Hang Hau District N.T., together with lift installations (by a Nominated Sub-contractor), associated builder's works and building services installations, and all necessary alterations, modification and improvement to existing buildings and subsequent reinstatement.</p> <p>The works at Caritas Fanling Chan Chun Ha Secondary School are scheduled to commence in November 2024 tentatively for completion in July 2026 tentatively. The works at CCC Kei Heep Secondary School are scheduled to commence in November 2024 tentatively for completion in May 2026 tentatively. The works at Cheng Chek Chee Secondary School of Sai Kung & Hang Hau District N.T. are scheduled to commence in November 2024 tentatively for completion in August 2026 tentatively.</p>

Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will <u>not</u> be accepted.</p> <p>If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or "extreme conditions after super typhoons" announced by the Government is/are in force at any time between 9:00 a.m. and 12:00 noon on Friday, 2 February 2024, the tender closing time will be postponed to 12:00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the "extreme conditions after super typhoons" announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9:00 a.m. and 12:00 noon on Friday, 2 February 2024, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
