### Japan-East Asia Network of Exchange for Students and Youths (JENESYS) Programme (2025/26 School Year)

#### SUMMARY

The purpose of this circular memorandum is to invite all government, aided and caput secondary schools and secondary schools under the Direct Subsidy Scheme (DSS secondary schools) to nominate student and/or teacher to join the JENESYS Programme sponsored by the Japanese Government.

#### DETAILS

2. At the Second East Asia Summit (EAS) held in January 2007, the Japanese Government announced a youth exchange programme to invite young people from the EAS member states (including members of the Association of Southeast Asian Nations, Australia, China, India, New Zealand and the Republic of Korea) to visit Japan, with a view to establishing a basis of Asia's solidarity through youth exchange. Hong Kong has been invited to join the JENESYS Programme since 2008. The Japanese Government has recently informed the Education Bureau (EDB) of the continuation of the JENESYS Programme in the 2025/26 school year and invited Hong Kong to continue participating in it.

3. Under the JENESYS Programme, the Hong Kong delegation, comprising 16 students and two teachers, will visit Japan from 7 to 13 December 2025. The activities scheduled in Japan include field visits, school attachments, homestay for cultural exchanges, etc. (The visit itinerary is subject to the final arrangement of the receiving party of Japan.)

4. Each government, aided, caput and DSS secondary school can nominate one Secondary Five student and/or one teacher to join the JENESYS Programme. As requested by the Japanese Government, the nominated students and teachers should possess a **valid Hong Kong Special Administrative Region (HKSAR) Passport**. Preference will be given to those students who have not participated in similar kind of programmes before and to those teachers who have experience in leading students for exchange programme(s), can communicate in Japanese and/or possess a valid first aid certificate.

5. EDB will invite suitable student and teacher nominees to attend an interview. The selection results for student-delegates and teacher-chaperons will be released in late November 2025 through their schools. Those who have not been notified after the said period may assume that their applications are unsuccessful. Successful applicants are required to attend all training sessions, pre-tour meetings, briefing sessions, rehearsals, etc. to be held from November to December 2025 (around 4 to 6 sessions in total). Failure to attend these activities may result in disqualification as a member of the delegation.

7. Schools interested in making nomination(s) are requested to submit the nomination form(s) and relevant documents on or before 29 September 2025 (Monday). Schools may submit the completed nomination form and upload the supporting documents via the Common Log-on System (<https://clo.edb.gov.hk/> or scan the QR Code on the right) (Common Log-on System > e-Form Submission System > e-Forms Application > Japan-East Asia Network of Exchange for Students and Youths (JENESYS) Programme Nomination Form (Student)/(Teacher) (2025/26)). Alternatively, schools may deliver the completed nomination form(s), together with the supporting documents by hand to the Student Special Support Section of EDB (address: Room 1141, 11/F, Wu Chung House, 213 Queen's Road East, Wanchi, Hong Kong).

**Japan-East Asia Network of Exchange  
for Students and Youths (JENESYS) Programme**

**1. Objective**

The JENESYS Programme aims to promote mutual understanding among the East Asia region, and to deepen Hong Kong students' understanding of Japan through the following activities:

- (a) Visiting to higher education institutions, museums, specific organisations for field studies;
- (b) Joining school attachment and activities to exchange with Japanese youths; and
- (c) Staying with Japanese host families and visiting to ancient cities and historical landmarks to experience Japanese culture.

**2. Nomination Criteria**

- (a) For student-delegates  
The nominee should:
  - (i) be a Secondary Five student;
  - (ii) have good common sense and good academic performance with other learning experiences outside classroom;
  - (iii) be able to communicate effectively in Putonghua and English, and preferably be able to speak Japanese;
  - (iv) be recommended by the Principal, who may consider students coming from needy families as appropriate; and
  - (v) possess a valid HKSAR Passport.
- (b) For teacher-chaperons  
The nominee should:
  - (i) be teaching senior secondary classes or have experience in leading senior secondary students for extra-curricular activities;
  - (ii) be proficient in Putonghua and English, and preferably be able to communicate in Japanese;
  - (iii) be recommended by the Principal; and
  - (iv) possess a valid HKSAR Passport.

(Preference is given to those teachers who have relevant experience in leading students for exchange programme(s), can communicate in Japanese and/or possess a valid first aid certificate.)

Please note:

The selection of student-delegates is independent of the teacher-chaperons. For a school which nominates both its student and teacher to participate in the JENESYS Programme, whether the student is selected will not affect the selection result of the

teacher from the same school and vice versa.

### **3. The JENESYS Programme**

The JENESYS Programme offers homestays, attachment to schools, seminars, visits to prefectures and cultural, social, economic, political, environmental and advanced technology facilities, etc. (The visit itinerary is subject to the final arrangement of the receiving party of Japan.)

### **4. Date of Visit**

The period of the exchange visit is from 7 to 13 December 2025.

### **5. Others**

- (a) The JENESYS Programme expenses such as air fares, local transport, board and lodging are provided by the Japanese Government.
- (b) The receiving party of Japan will arrange insurance policy covering the period of visit for the Hong Kong delegation<sup>1</sup>. EDB does not bear any responsibilities for any loss, damage or injury which is not under the coverage of the Block Insurance Policy.
- (c) Successful nominees should acquire a comprehensive travel insurance at their own costs, and based on individual needs to expand the coverage for unexpected circumstances such as accident, loss of baggage, personal property, etc.

### **6. Obligations of the Delegates**

- (a) Student-delegates are required to:
  - (i) behave properly, be disciplined, and perform all responsibilities and obligations as required;
  - (ii) attend all pre-tour meetings, training sessions, briefing sessions, rehearsals, etc.;
  - (iii) prepare relevant materials on Hong Kong for presentation to the receiving parties;
  - (iv) participate in talent shows during the exchange visit;
  - (v) complete an individual evaluation form after the exchange visit;
  - (vi) complete a group report on the outcome of the exchange visit within one and a half months after the visit; and
  - (vii) attend relevant functions as and when invited or requested by EDB or the sponsor.
- (b) Teacher-chaperons are required to:
  - (i) be responsible and be committed to serve as a role model for student-

- delegates;
- (ii) attend all pre-tour meetings, training sessions, briefing sessions, rehearsals, etc.;
- (iii) plan for the talent shows and conduct training programmes for the student-delegates;
- (iv) lead student-delegates to prepare relevant materials on Hong Kong for presentations to the receiving parties;
- (v) assist in the administrative work, logistic arrangement and rehearsals of the delegation prior to departure;
- (vi) lead a group of student-delegates and carry out the related duties as a teacher-chaperon;
- (vii) take care of the student-delegates and deal with their discipline and behavioral problem during the exchange visit;
- (viii) complete an individual evaluation form after the exchange visit;
- (ix) guide the student-delegates in completing the group report on the outcome of the exchange visit within one and a half months after the visit;
- (x) complete a report about the exchange visit and share their experience on how they are going to facilitate student-delegates to learn from the JENESYS Programme within two months after the visit; and
- (xi) attend relevant functions as and when invited or requested by EDB or the sponsor.

## **7. Submission of Documents**

School should submit the following documents for each nominee on or before 29 September 2025:

- (a) Student nominee
  - (i) duly-completed nomination form (at Annex II);
  - (ii) copies of the last two examination reports in Secondary Four;
  - (iii) a copy of the supporting document(s) of his / her proficiency in / studying of Japanese, if any; and
  - (iv) a copy of the supporting document(s) of his / her outstanding performance in Putonghua and/or English, if any.
- (b) Teacher nominee
  - (i) duly-completed nomination form (at Annex III);
  - (ii) copies of any other documents that are useful in supporting the application;
  - (iii) a copy of the supporting document(s) of his / her proficiency in / studying of Japanese, if any; and
  - (iv) a copy of the first aid certificate, if any.

## **8. Interview**

Suitable student and teacher nominees may be invited to attend an interview. Both interviews will be held in October 2025.
